"D.C. Minority Bank Encouragement Amendment Act of 1988".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-471 on first and second readings October 25, 1988, and November 15, 1988, respectively. Following the signature of the Mayor on December 1, 1988, this legislation was assigned Act No. 7-249, published in the December 16, 1988, edition of the D.C. Register, (Vol. 35 page 8648) and transmitted to Congress on January 23, 1989 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-187, effective March 16, 1989.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend the District of Columbia Regional Interstate
Banking Act of 1985, the District of Columbia Savings
and Loan Acquisition Amendment Act of 1988 and the
District of Columbia Depository Act of 1977 to
encourage the District of Columbia government and
recipients of contracts from the District of Columbia
government to use women-owned and minority-owned banks
and savings and loan associations.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Minority Bank Encouragement Amendment Act of 1988".

Sec. 2. The District of Columbia Regional Interstate Banking Act of 1985, effective November 23, 1985 (D.C. Law 6-63; D.C. Code, sec. 26-801 et seq.), is amended as follows:

(a) Section 2 (D.C. Code, sec. 26-801) is amended by adding a new paragraph (22) at the end to read as follows: "(22) 'Women-owned' means that at least 51% of the bank is owned by a woman or women who make the policy decisions and actively manage day-to-day operations.".

(b) A new section 10b is added to read as follows:
"Sec. 10b (a) Recipients of District of Columbia
government contracts are encouraged to use women-owned banks
and federally or District chartered minority-owned banks
certified by the Minority Business Opportunity Commission in
accordance with the District of Columbia Minority
Contracting Act of 1976, effective March 29, 1977 (D.C. Law
1-95; D.C. Code, sec. 1-1141 et seq.).

"(b) The Mayor shall, pursuant to title 1 of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1203; D.C. Code, sec. 1-1501 et seq.), issue rules to implement the provisions of this section within 90 days of the effective date of the District of Columbia Minority Bank Encouragement Act of 1988. All

rules issued pursuant to this subsection shall be transmitted to the Council for review.".

Sec. 3. The District of Columbia Savings and Loan Acquisition Amendment Act of 1988, effective October 12, 1988 (D.C. law 7-175; D.C. Code, sec. 26-901 et seq.), is amended as follows:

"(a) Section 2 (D.C. Code, sec. 26-901) is amended by

adding a new paragraph (29) to read as follows:

'(29) 'Women-owned' means that at least 51% of the savings and loan association is owned by a woman or women who make the policy decisions and actually manage day-to-day operations.".

"(b) A new section 17a is added to read as follows: New, Section "'Sec. 17a (a). Recipients of the District of Columbia 26-917 government contracts are encouraged to use federally and

District chartered minority-owned savings and loan associations certified by the Minority Business Opportunity Commission in accordance with the District of Columbia Minority Contracting Act of 1976, effective March 29, 1977

(D.C. Law 1-95; D.C. Code, sec. 1-1141 et seq.).
"'(b) The Mayor shall, pursuant to title 1 of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1203; D.C. Code, sec. 1-1501 et seq.), issue rules to implement the provisions of this section within 90 days of the effective date of the District of Columbia Minority Bank Encouragement Act of 1988. All rules issued pursuant to this subsection shall be transmitted to the Council for review. '".

Sec. 4. Section 5(a) of the District of Columbia Depository Act of 1977, effective October 26, 1977 (D.C. Law 2-32; D.C. Code, sec. 47-344(a)), is amended as follows:
(a) By striking the number "5" in the first sentence

- and inserting the number "6" in its place; and
 (b) By adding a new paragraph (6) to read as follows: "(6) Women-ownership or certification as minority owned by the Minority Business Opportunity Commission in accordance with the District of Columbia Minority Contracting Act of 1976, effective March 29, 1977 (D.C. Law 1-95; D.C. Code, sec. 1-1141 et seq.). For purposes of this paragraph the term 'women-ownership' means that at least 51% of the business enterprise is owned by a woman or women who make policy decisions and actively manage the day-to-day operations.".
- Sec. 5. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as

provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
