
NOTICE

D.C. LAW 7-33

"Citizens Energy Advisory Committee Extension
Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-155 on first and second readings, June 16, 1987, and June 30, 1987, respectively. Following the signature of the Mayor on July 23, 1987, this legislation was assigned Act 7-61, published in the August 14, 1987, edition of the D.C. Register, (Vol. 34 page 5314) and transmitted to Congress on July 29, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-33, effective October 9, 1987.

D.C. ACT 7-61

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUL 23 1987

To amend the District of Columbia Office of Energy Act of 1980 to extend the life of the Citizens Energy Advisory Committee and to make technical and clarifying amendments.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Citizens Energy Advisory Committee Extension Amendment Act of 1987".

Sec. 2. Section 7 of the District of Columbia Office of Energy Act of 1980, effective March 4, 1981 (D.C. Law 3-132; D.C. Code, sec. 1-1906), is amended as follows:

(a) Subsection (a) is amended by adding the phrase "(Committee)" after the phrase "Citizens Energy Advisory Committee".

(b) Subsection (b) is amended to read as follows:

"(b) The purpose of the Committee is to advise the Mayor, the Council, and the Office regarding important energy issues, including energy supplies, energy costs, energy demands and conservation, financing mechanisms, the special needs of low-income, displaced family and elderly households, emergency procedures, and other matters. The Committee shall receive, to the maximum extent possible, staff support from the Office. The Committee shall also advise the Mayor, the Council, and the Office on District energy policies and programs, as well as the organization and effectiveness of the Office. Nothing in this section shall be interpreted as supplanting the oversight role of the Council on energy matters in the District. The Committee's advice to the Mayor, the Council, and the Office shall include the following:

"(1) The creation of financing mechanisms adequate to insure an energy program which can properly protect the interests of District citizens through vigorous application of conservation and renewable technologies;

"(2) The creation of effective conservation programs, with particular attention to devising means and incentives for conserving energy in tenant-occupied housing;

"(3) The means of insuring equity in the allocation of energy costs, especially in regard to their impact on low- and moderate-income residents;

"(4) The means of maximizing citizen involvement in the programs of the Office, especially through programs which are neighborhood-based; and

"(5) The means of maximizing the job creation potential inherent in the energy issue."

(c) Subsection (d)(1) is amended by striking the phrase "Public Services and Cable Television" and inserting the phrase "the Council committee having oversight over energy matters in the District" in its place.

(d) Subsection (e) is amended by striking the phrase "six (6) years" and inserting the phrase "10 years" in its place.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of a veto by the Mayor, action by the Council to override the veto), as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
