Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198.

"the Act", the Council of the District of Columbia adopted Bill No. 7-221 on first and second readings, June 16, 1987, and June 30, 1987, respectively. Following the signature of the Mayor on July 23, 1987, this legislation was assigned Act 7-64, published in the August 14, 1987, edition of the <u>D.C. Register</u>, (Vol. 34 page 5321) and transmitted to Congress on July 29, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-36, effective October 9, 1987.

D.C. ACT 7 - 64

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUL 2 3 1987

To approve precinct boundary changes proposed by the Board of Elections and Ethics and to amend the District of Columbia Election Code of 1955 to permit future approvals by resolution.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Precinct Boundary Changes Approval and Procedural Amendment Act of 1987".

Sec. 2. Pursuant to section 5(a)(8) of the District of Columbia Election Code of 1955, approved August 12, 1955 (69 Stat. 700; D.C. Code, sec. 1-1306(a)(8)), the Council of the District of Columbia approves the proposed boundary divisions for Precincts 50, 71, and 112 submitted by the Board of Elections and Ethics on April 21, 1987, and approves the proposed boundary line between Precincts 11 and 12 submitted by the Board of Elections and Ethics on June 4, 1987.

Sec. 3. Section 5(a)(8) of the District of Columbia Election Code of 1955, approved August 12, 1955 (69 Stat. 700; D.C. Code, sec. 1-1306(a)(8)), is amended by striking the phrase "subject to the approval of the Council" and inserting in its place the phrase "subject to the approval of the Council, in whole or in part, by resolution".

Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,
