### D.C. LAW 7-52

"Public Defender Service Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-173 on first and second readings, July 14, 1987, and September 29, 1987, respectively. Following the signature of the Mayor on October 16, 1987, this legislation was assigned Act 7-85, published in the October 30, 1987, edition of the D.C. Register, (Vol. 34 page 6891) and transmitted to Congress on October 21, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-52, effective December 10, 1987.

# D.C. ACT 7 - 85

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

### OCT 1 6 1987

To amend Title III of the District of Columbia Court Reform and Criminal Procedure Act of 1970 to authorize attorneys of the Public Defender Service to represent inmates in District of Columbia corrections facilities in administrative matters related to their incarceration.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Public Defender Service Amendment Act of 1987".

Sec. 2. Title III of the District of Columbia Court Reform and Criminal Procedure Act of 1970, approved July 29, 1970 (84 Stat. 654; D.C. Code, sec. 1-2701 et seq.), is amended as follows:

Section 302(a) (D.C. Code, sec. 1-2702(a)(1)) is amended by adding a new subparagraph (8) to read as follows: sec. 1-2702

D.C. Code,

"(8) Persons incarcerated in District of Columbia (1988 supp.) corrections facilities, not including community residential facilities or community-based corrections facilities, in administrative matters related to their incarceration before any court or administrative body.".

(b) Section 302(a) (D.C. Code, sec. 1-2702(a)(2)) is amended by inserting immediately before the sentence beginning with the word "Representation" the following:

D.C. Code, sec. 1-2702 (1988 supp.)

"The Service shall not represent an inmate in a suit for damages against the District of Columbia or its employees for conduct within the scope of their employment, nor shall it represent an inmate in a suit in which the payment of attorney's fees or costs is sought against the District of Columbia or its employees for conduct within the scope of their employment.".

(c) Section 305(a) (D.C. Code, sec. 1-2705(a)) is amended by striking the word "defense" in the first sentence.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
