D.C. LAW 7-57

"Day Care Policy Act of 1979 Amendment Temporary Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-305 on first and second readings, September 29, 1987, and October 13, 1987, respectively. Following the signature of the Mayor on October 26, 1987, this legislation was assigned Act 7-90, published in the November 6, 1987, edition of the D.C. Register, (Vol. 34 page 7081) and transmitted to Congress on October 27, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-57, effective December 16, 1987.

## D.C. ACT 7 - 90

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

## OCT 2 6 1987

To amend, on a temporary basis, the Day Care Policy Act of 1979 to increase payments to child development centers, child development homes, and in-home caregivers.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Day Care Policy Act of 1979 Amendment Temporary Act of 1987".

Sec. 2. The Day Care Policy Act of 1979, effective September 19, 1979 (D.C. Law 3-16; D.C. Code, sec. 3-301 et seq.), is amended as follows:

(a) Section 10(a) (D.C. Code, sec. 3-309(1)) is

amended to read as follows:

"(a) Subject to subsections (b) through (f) of this section, payments to child development centers for care of these children shall be made on a monthly basis according to the following rates, effective October 1, 1987:

"(1) Full day care - \$15.50 per day for each child, plus \$1.00 per day for each child when the center

provides transportation;

- "(2) Part-time care \$7.75 per day for each child; \$12.40 per day for each child for full-time care provided during vacations and summer to a child who otherwise receives only part-time care or does not receive care; and
- "(3) No child development center shall be paid more than its stated rate, prior to application of its sliding fee scale, for children not eligible for subsidized care.".
- (b) Section 11 (D.C. Code, sec. 3-310) is amended to read as follows:
- "Sec. 11. Payments to child development homes and to in-home caregivers shall be made according to the following rates, effective October 1, 1987:

"(1) Full day care:

D.C. Code, sec. 3-309 (1988 supp. "(A) Child development homes - \$10.50 per

child per day;

"(B) In-home care:

"(i) For care during the day - \$5.75

per child per day;

"(ii) For care during night hours -

\$6.75 per child per night;

"(2) Part-time care:

"(A) Child development homes - \$5.25 per

child per day for before- and after-school care;

"(B) In-home care:

"(i) Before- and after-school care -

\$4.25 per child per day;

"(ii) For night care of less than 6

hours - \$3.50 per child per night.".

Sec. 3(a). This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).

(b) This act shall expire on the 225th day of its
