D.C. LAW 7-78

"Codification Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-179 on first and second readings, October 27, 1987, and November 10, 1987, respectively. Following the signature of the Mayor on November 24, 1987, this legislation was assigned Act 7-113, published in the December 11, 1987, edition of the D.C. Register, (Vol. 34 page 7956) and transmitted to Congress on December 1, 1987 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-78, effective February 18, 1988.

AN ACT

D.C. ACT 7-113

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

NOV 24 1987

To amend the District of Columbia Codification Act of 1975 to require the publication of emergency acts in the District of Columbia Statutes-at-large, and to exempt ceremonial resolutions from this publication requirement.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Codification Amendment Act of 1987".

Sec. 2. Section 205(a) of the District of Columbia Codification Act of 1975, effective October 8, 1975 (D.C. Law 1-19; D.C. Code, sec. 1-1603(a)), is amended as follows:



(a) Subsection (1) is amended by inserting after the word "acts" the phrase ", including emergency acts adopted after December 31, 1986,"; and


(b) Subsection (2) is amended by inserting after the word "year" the phrase ", except ceremonial resolutions adopted after December 31, 1986".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
