D.C. LAW 7-87

"District of Columbia Health Occupations
Revision Act of 1985 Amendment Act of 1987".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 7-211 on first and second readings, November 24, 1987, and December 8, 1987, respectively. Following the signature of the Mayor on December 22, 1987, this legislation was assigned Act 7-125, published in the January 8, 1988, edition of the D.C. Register, (Vol. 35 page 162) and transmitted to Congress on January 22, 1988 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 7-87, effective March 11, 1988.

AN ACT

D.C. ACT 7 - 125

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

DEC 22 1987

To amend the District of Columbia Health Occupations Revision Act of 1985 to extend the time during which the Board of Social Work shall accept applications from practicing social workers for waiver of educational and examination licensing requirements and to extend the time during which the Board of Dietetics and Nutrition shall accept applications from practicing dietitians and nutritionists for waiver of examination requirements.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Health Occupations Revision Act of 1985 Amendment Act of 1987".

Sec. 2. The District of Columbia Health Occupations Revision Act of 1985, effective March 25, 1986 (D.C. Law 6-99; D.C. Code, sec. 2-3301.1 et seq.), is amended as follows:


(a) Section 702 (D.C. Code, sec. 2-3307.2) is amended D.C. Code, sec. by deleting the number "12" and inserting in its place the ^{2-3307.2} number "24". (1988 supp.)


(b) Section 806 (D.C. Code, sec. 2-3308.6) is amended: D.C. Code, sec. (1) In subsection (a), by deleting the number 2-3308.6 "12" the second time it appears and inserting in its place (1988 supp.) the number "24"; and

(2) In subsection (b), by deleting the number "12" and inserting in its place the number "24".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act,

approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)).
