

D.C. LAW 8-199

"Washington Convention Center Management Act
of 1979 Amendment Act of 1990".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-447 on first and second readings, October 9, 1990, and October 23, 1990, respectively. Following the signature of the Mayor on November 8, 1990, this legislation was assigned Act No. 8-262, published in the November 23, 1990, edition of the D.C. Register, (Vol. 37 page 7332) and transmitted to Congress on January 11, 1991 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-199, effective March 6, 1991.

AN ACT

D.C. ACT 8 - 262

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

NOV 08 1990

To amend the Washington Convention Center Management Act of 1979 to allow Convention Center Board of Directors to serve more than 2 consecutive terms and to require Council approval of nominations to the Board before nominations of Board members are deemed confirmed.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Washington Convention Center Management Act of 1979 Amendment Act of 1990".


Sec. 2. Section 3(c) of the Washington Convention Center Management Act of 1979, effective November 3, 1979 (D.C. Law 3-36; D.C. Code, sec. 9-602(c)), is amended to read as follows:


"(c) The Mayor shall, from time to time, designate the Chairman of the Board. The members of the Board shall serve for a term of 3 years, beginning on the date the member is confirmed, except that with respect to the members first appointed under this section, the Chairman shall serve for a term of 3 years, 2 members shall serve for a term of 2 years, and 2 members shall for a term of 1 year, as determined by the Mayor. If a member is not renominated to the Board, the member shall serve until a successor has been nominated and confirmed. Any person appointed to fill a vacancy on the Board shall be appointed only for the unexpired term of the member whose vacancy is being filled. A member filling a vacancy may be reappointed, and if not reappointed, shall serve until a successor has been nominated and confirmed. Within 30 days after a term expires or a vacancy occurs on the Board, the Mayor shall appoint a nominee for the vacant or expired membership on the Board. The Council may approve or disapprove the nomination by resolution within 45 days of the date the nomination is transmitted to the Council, excluding Saturdays, Sundays, legal holidays, and days of Council

recess. If the Council does not act within the 45-day period, the nomination shall be deemed disapproved.

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
