D.C. LAW 8-2

"Law Enforcement Officers Memorial Act of 1989".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-91 on first and second readings, February 28, 1989, and March 14, 1989, respectively. Following the signature of the Mayor on March 29, 1989, this legislation was assigned Act No. 8-12, published in the April 7, 1989, edition of the <u>D.C. Register</u>, (Vol. 36 page 2371) and transmitted to Congress on April 6, 1989 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-2, effective May 23, 1989.

D.C. ACT 8 - 12

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAR 2 9 1989

To authorize the National Law Enforcement Officers Memorial Fund, Inc., to erect on Federal land in the District of Columbia a memorial to law enforcement officers who die in the line of duty.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Law Enforcement Officers Memorial Act of 1989".

Sec. 2. The National Law Enforcement Officers Memorial Fund, Inc., is authorized to establish the National Law Enforcement Heroes Memorial on Federal land in the District of Columbia or its environs to honor law enforcement officers who die in the line of duty.

Sec. 3. (a) The Mayor shall obtain and review the design and plans for the memorial and, after consultation with the Council and the Joint Committee on Judicial Administration of the District of Columbia Courts, transmit recommendations to the Secretary of the Interior, the Commission of Fine Arts, and the National Capital Planning Commission before approval of the design, plans, and construction of the memorial in accordance with the Joint Resolution Authorizing the Law Enforcement Officers Memorial Fund to establish a memorial in the District of Columbia or its environs, approved October 19, 1984 (98 Stat. 2712) ("Joint Resolution").

New, Section 4-1122

- (b) Construction shall not commence until the Secretary of the Interior determines that sufficient funds are available for the completion of the memorial in accordance with the Joint Resolution.
- (c) Construction shall commence no later than October 19, 1989, as provided in the Joint Resolution.

Sec. 4. The District of Columbia shall not pay any expenses of the establishment or maintenance of the memorial.

Sec. 5. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
