D.C. LAW 8-58

"Construction Codes Temporary Amendment Act of 1989".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-344 on first and second readings, July 11, 1989, and September 26, 1989, respectively. Following the signature of the Mayor on October 13, 1989, this legislation was assigned Act No. 8-88, published in the October 27, 1989, edition of the D.C. Register, (Vol. 36 page 7382) and transmitted to Congress on October 18, 1989 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-58, effective January 30, 1990.

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT 1 3 1989

To amend, on a temporary basis, the Construction Codes
Approval and Amendments Act of 1986 to authorize the
denial of a building permit when necessary to protect
the security and safety of the President or Vice
President of the United States.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Construction Codes Temporary Amendment Act of 1989".

Note 1-229

Sec. 2. Section 4 of the Construction Codes Approval and Amendments Act of 1986, effective March 21, 1987 (D.C. Law 6-216; D.C. Code, sec. 5-1303), is amended by adding a new subsection (d) to read as follows:

Note, 5-1303

"(d) No permit required under the Construction Codes shall be issued if it is determined by the Director of the Department of Consumer and Regulatory Affairs that the United States Secret Service has established that the issuance of the permit would adversely impact the safety and security of the President or Vice President of the United States.".

Note, 5-1303

Sec. 3. Section 2 shall apply to each permit application that has not been granted by the Director of the Department of Consumer and Regulatory Affairs on the effective date of this act.

Sec. 4. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia

Statutes-at-Large, or the District of Columbia Municipal Regulations.

(b) This act shall expire on the 225th day of its having taken effect.
