D.C. LAW 8-70

"Construction Codes Amendment Act of 1989".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 8-345 on first and second readings, October 10, 1989, and October 24, 1989, respectively. Following the signature of the Mayor on November 2, 1989, this legislation was assigned Act No. 8-107, published in the November 10, 1989, edition of the <u>D.C. Register</u>, (Vol. 36 page 7744) and transmitted to Congress on November 6, 1989 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 8-70, effective February 27, 1990.

D.C. ACT 8 - 19 7

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

NOV 0 2 1989

To amend the Construction Codes Approval and Amendments Act of 1986 to authorize the denial of a building permit when necessary to protect the security and safety of the President or Vice President of the United States.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Construction Codes Amendment Act of 1989".

Sec. 2. (a) Section 4 of the Construction Codes Approval and Amendments Act of 1986, effective March 21, 1987 (D.C. Law 6-216; D.C. Code, sec. 5-1303), is amended by adding a new subsection (d) to read as follows:

Section 5-1303

"(d)(1) No permit required under the Construction Codes shall be issued if it is determined by the Mayor that:

"(A) The permit affects an area in close promixity to the official residence of the President or the Vice President of the United States; and

"(B) The United States Secret Service has established that the issuance of the permit would adversely impact the safety and security of the President or the Vice President of the United States:

"(2) This subsection shall apply to each permit application that has not been granted by the Mayor on the effective date of the Construction Codes Amendment Act of 1989.".

Sec. 3. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia

Statutes-at-Large, or the District of Columbia Municipal Regulations.
