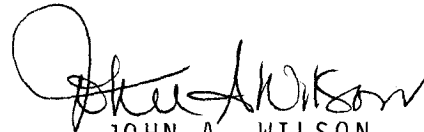

D.C. LAW 9-12

"District of Columbia Government Comprehensive Merit Personnel Act of 1978 Operation Desert Shield and Desert Storm Active Duty Pay Differential Amendment Act of 1991".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-149 on first and second readings, April 9, 1991, and May 7, 1991, respectively. Following the signature of the Mayor on May 17, 1991, this legislation was assigned Act No. 9-30, published in the May 31, 1991, edition of the D.C. Register, (Vol. 38 page 3376) and transmitted to Congress on May 23, 1991 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-12, effective July 13, 1991.

AN ACT

D.C. ACT 9-30

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

MAY 17, 1991

To amend the District of Columbia Government Comprehensive Merit Personnel Act of 1978 to allow District government employees who serve in the military reserve forces and who are called into active duty to receive a pay differential.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "District of Columbia Government Comprehensive Merit Personnel Act of 1978 Operation Desert Shield and Desert Storm Active Duty Pay Differential Amendment Act of 1991".

Sec. 2. The District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code, sec. 1-601.1 et seq.), is amended as follows:

1-612.3

(a) Section 1103(a) (D.C. Code, sec. 1-612.3(a)) is amended by adding a new paragraph 6 to read as follows:

"(6) Any full-time permanent, term, or TAPER District government employee who serves in a reserve component of the United States Armed Forces who was or will be called to active duty as a result of Operation Desert Shield and Desert Storm shall receive, upon application and approval, an amount that equals the difference in compensation between the employee's District government basic pay reduced by the employee's basic military pay. This amount shall not be considered as basic pay for any purpose and shall be paid for any period during which the employee is carried in a non-pay status from the time the employee is called into active duty, following the formal inception of Operation Desert Shield and Desert Storm, until the employee is released from active duty or until September 31, 1992, whichever occurs sooner."

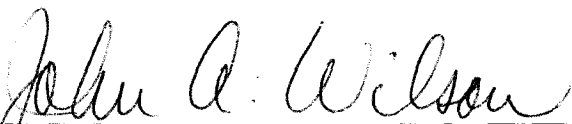
(b) Section 1111(d) (D.C. Code, sec. 1-612.11(d)), is amended as follows:

- (1) By striking the word "and" after the figure "(3)" and adding a comma in its place; and
(2) By adding the phrase ",and (6)" after the figure "(4)".

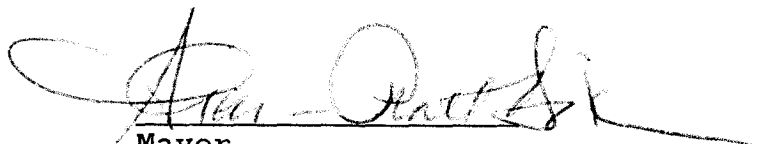
Sec. 3. The Mayor shall, pursuant to Title 1 of the District of Columbia Administrative Procedure Act, approved October 21, 1968 (82 Stat. 1204; D.C. Code, sec. 1-1501 et seq.), issue rules within 30 days of the effective date of the District of Columbia Government Comprehensive Merit Personnel Act of 1978 Operation Desert Shield and Desert Storm Active Duty Pay Differential Amendment Act of 1991 to implement the provisions of this act.

Sec. 4. This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code, sec. 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.
