

D.C. LAW 9-148

"Bureau of Traffic Adjudication Hearing
Examiner Temporary Amendment Act of 1992".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-521 on first and second readings, May 6, 1992, and June 2, 1992, respectively. Following the signature of the Mayor on June 19, 1992, this legislation was assigned Act No. 9-228, published in the July 3, 1992, edition of the D.C. Register, (Vol. 39 page 4915) and transmitted to Congress on June 24, 1992 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-148, effective September 10, 1992.

District of Columbia Code

D.C. ACT 9-228

(1993 Supplement)

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

JUNE 19, 1992

To amend, on a temporary basis, the District of Columbia Traffic Adjudication Act of 1978 to permit the appointment of hearing examiners of the Bureau of Traffic Adjudication for additional 2-year terms.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Bureau of Traffic Adjudication Hearing Examiner Temporary Amendment Act of 1992".

Sec. 2. Section 104(a) of the District of Columbia Traffic Adjudication Act of 1978, effective September 12, 1978 (D.C. Law 2-104; D.C. Code §40-604(a)), is amended to read as follows:


Note, Section
40-604

"(a) The Director shall appoint and prescribe the duties of a Chief Hearing Examiner and other hearing examiners as are necessary to implement the provisions of this act. The Chief Hearing Examiner and hearing examiners shall be appointed for initial terms of 5 years and shall be eligible for reappointment for additional terms of 2 years. The Chief Hearing Examiner and each hearing examiner appointed pursuant to this section shall serve, during their terms, as career service employees in accordance with section 801 of the District of Columbia Government Comprehensive Merit Personnel Act of 1978, effective March 3, 1979 (D.C. Law 2-139; D.C. Code §1-608.1)."


Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code §1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

(b) This act shall expire on the 225th day of its having taken effect or upon the effective date of the Bureau of Traffic Adjudication Hearing Examiner Amendment Act of 1992, whichever occurs first.
