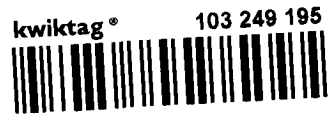

NOTICE

D.C. LAW 9-181

"Fraternal Benefit Association Beneficiaries
Designation Temporary Amendment Act of 1992".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-581 on first and second readings, July 7, 1992, and October 6, 1992, respectively. Following the signature of the Mayor on October 23, 1992, this legislation was assigned Act No. 9-300, published in the November 6, 1992, edition of the D.C. Register, (Vol. 39 page 8081) and transmitted to Congress on January 5, 1993 for a 30-day review, in accordance with Section 602(c)(1) of the Act.

The Council of the District of Columbia hereby gives notice that the 30-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-181, effective March 13, 1993.

AN ACT

D.C. ACT 9-300

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

OCT. 23, 1992

To amend, on a temporary basis, An Act To establish a code of law for the District of Columbia to allow members of fraternal benefit associations to freely designate beneficiaries.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Fraternal Benefit Association Beneficiaries Designation Temporary Amendment Act of 1992".


Sec. 2. Section 749 of An Act To establish a code of law for the District of Columbia, approved March 3, 1901 (31 Stat. 1310; D.C. Code § 35-1201), is amended by adding the phrase "any person, organization, or institution designated by the member, including, but not limited to," after the phrase "The payment of death benefits shall be to".

Sec. 3. (a) This act shall take effect after a 30-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(1) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code § 1-233(c)(1)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

(b) This act shall expire on the 225th day of its having taken effect or upon the effective date of the Fraternal Benefit Association Designation Act of 1992, whichever occurs first.
