D.C. LAW 9-270

"Carjacking Prevention Temporary Amendment Act of 1992".

Pursuant to Section 412 of the District of Columbia Self-Government and Governmental Reorganization Act, P. L. 93-198, "the Act", the Council of the District of Columbia adopted Bill No. 9-629 on first and second readings, October 6, 1992, and November 4, 1992, respectively. Following the signature of the Mayor on November 25, 1992, this legislation was assigned Act No. 9-328, published in the December 11, 1992, edition of the <u>D.C. Register</u>, (Vol. 39 page 9223) and transmitted to Congress on January 6, 1993 for a 60-day review, in accordance with Section 602(c)(2) of the Act.

The Council of the District of Columbia hereby gives notice that the 60-day Congressional Review Period has expired, and therefore, cites this enactment as D.C. Law 9-270, effective May 8, 1993.

AN ACT District of Columbia Code

D.C. ACT 9-328 (1993 Supplement)

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

NOVEMBER 25, 1992

To amend, on a temporary basis, An Act to establish a code of law for the District of Columbia and to amend section 23-1331(4) of the District of Columbia Code to create the criminal offense of carjacking.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Carjacking Prevention Temporary Amendment Act of 1992".

Sec. 2. An Act to establish a code of law for the District of Columbia, approved March 3, 1901 (31 Stat. 1322 *et seq.*; D.C. Code § 22-2901 *et seq.*), is amended by adding a new section 811a to read as follows:

Note, Section 22-2902

"Sec. 811a. Carjacking.

"(a)(1) A person commits the offense of carjacking if, by any means, that person knowingly or recklessly by force or violence, whether against resistance or by sudden or stealthy seizure or snatching, or by putting in fear, or attempts to do so, shall take from another person immediate actual possession of a person's motor vehicle.

"(2) A person convicted of carjacking shall be fined not more than \$5,000 and be imprisoned for a mandatory-minimum term of not less than 7 years and not more than 21 years, or both.

"(b)(1) A person commits the offense of armed carjacking if that person while armed with or having readily available any pistol or other firearm (or imitation thereof) or other dangerous or deadly weapon (including a sawed-off shotgun, shotgun, machine gun, rifle, dirk, bowie knife, butcher knife, switch-blade knife, razor, blackjack, billy or metallic, or other false knuckles) commits or attempts to commit the offense of carjacking.

"(2) A person convicted of armed carjacking shall be fined not more than \$10,000 and be imprisoned for a mandatory-minimum term of not less than 15 years and not more than 45 years, or both.".

Sec. 3. Section 23-1331(4) of the District of Columbia Code is amended by inserting the phrase "armed carjacking" after the phrase "assault with a dangerous weapon".

Sec. 4. Section 8 of the District of Columbia Good Times Credit Act of 1986, effective April 11, 1987 (D.C. Law 6-218; D.C. Code § Note, Section 23-1331 24-434), is amended by inserting the phrase "and 811a" after the phrase "section 801" and inserting the phrase "and § 22-2903 (1993 Supp.)" after the phrase "22-2404(b),".

Sec. 5. Effective date.

(a) This act shall take effect after a 60-day period of Congressional review following approval by the Mayor (or in the event of veto by the Mayor, action by the Council of the District of Columbia to override the veto) as provided in section 602(c)(2) of the District of Columbia Self-Government and Governmental Reorganization Act, approved December 24, 1973 (87 Stat. 813; D.C. Code 1-233(c)(2)), and publication in either the District of Columbia Register, the District of Columbia Statutes-at-Large, or the District of Columbia Municipal Regulations.

(b) This act shall expire on the 225th day of its having taken effect.
